**MEMBERSHIP:**

I have read, signed and agreed to abide by the rules of the RNZAF Auckland Aviation Sports Club (Power Section) (referred to in the rest of this document as ASC). My total subscription has been paid and I understand my membership may be terminated at any time by the Base Commander, RNZAF Base Auckland.

I also understand that part of my membership obligation is to go on the Duty Roster once per year. I understand that I can either nominate a suitable date or I will be allocated a date. If the allocated date is unsuitable to me, it is my responsibility to organise a swap with another member.

**INSURANCE EXCESS:**

I understand that the payment of the Insurance Excess Fee (included in the membership fee) is mandatory for all members, and that this ensures that the ASC will pay the Insurance Excess for any damage caused by or occurring to an ASC aircraft, whether owned or leased, unless caused through my negligence as determined by the Chief Executive Officer of the ASC, or the relevant insurance company.

I hereby agree to accept full personal liability for the Insurance Excess if damage occurs to an aircraft or property whilst I am pilot in command of an ASC aircraft, whether owned or leased, is caused through negligence on my behalf as determined by the CEO at the ASC or the relevant insurance company. I understand that 'negligence' includes being in contravention of CAA rules and regulations, and the ASC Operations Manual.

I understand that club members flying 'Temporary Hire Category Aircraft' are not covered by this insurance excess, and that when flying 'Private Category Aircraft', I am responsible for making my own insurance arrangements.

**DAMAGES:**

I acknowledge and agree that in the event of suffering injury or damage of any nature, or any other person or persons suffering injury or damage of any nature, arising directly from the activities of the ASC and its members, officers, servants or agents, I (and my dependants) will bear the loss, and will not have any claim of any nature whatsoever against the ASC, its members, officers, servants or agents.
